Enforcement Case Study - NEORSD

Scott Broski, Superintendent Environmental Services, NEORSD

Hazardous Spill Case Study – Stream Studies and Ecological Response Following the February 2023 Train Derailment in East Palestine Bill Zawiski, Ohio EPA

Bill Zawiski has been employed by the Ohio EPA since 1989 and is currently an environmental supervisor in Ohio EPA's Northeast District. Bill received his bachelor's and master's degrees in biology from the University of Akron. The Division of Surface Water ensures compliance with the federal Clean Water Act and works to increase the number of water bodies that can be safely used for swimming and fishing. The division issues permits to regulate wastewater treatment plants, factories and storm water runoff; develops comprehensive watershed plans aimed at improving polluted streams. Trained as a biologist, Bill has worked for years with the Ohio Environmental Protection Agency. He has worked on permits for both industrial and municipal dischargers. He has taken an active role in the movement in this area to remove dams to improve the quality of rivers. Bill has coauthored several professional publications on dams and water quality.
